CANDIDATE QUALIFICATIONS FOR TRI-COUNTY BOWLING HALL OF FAME MEMBERSHIP (use official form only)

1. The candidate (man or woman) must have participated in, or promoted the game of bowling for ten years or more in Summit, Portage or Medina County.
2. A candidate for **Bowling Achievement** shall have competed in Local, State, National or International ABC, WIBC or USBC events and any other events sanctioned by ABC, WIBC or USBC and received recognition in one or more of the following categories:
 - A. Have been a participating member of a recognized team that finished in the top five of a Local, State, National or International event.
 - B. Have finished in the top five of a Local, State, National or International Singles or Doubles event.
 - C. Have been selected as a recipient of an individual bowling award or honor on a Local, State, National or International level.
 - D. *Have been selected as a member of an Honorary bowling team on a Local, State, National or International level.*
3. A candidate for Service to Bowling may be nominated on the basis of Years of Dedicated Service, and his or her contribution or influence on the game of bowling.
