Rules & Regulations - All Rules To Be Strictly Adhered To - No Exceptions

- 1) Only members of the Summit County USBC who are certified for the current season are eligible to compete in this tournament.
- 2) You must pay local association dues if not already certified in Summit County USBC. If not paid prior to bowling, bowlers scores will be voided.
- 3) Only female members of the Summit County USBC are eligible to compete in Womens only events in this tournament.
- 4) Tournament will be handicapped as follows:
 - Team – 90% of 880 scratch
 - Singles – 90% of 220 scratch
 - Doubles – 90% of 440 scratch
 - All Events – 90% of 660 scratch
- 5) All bowlers must use their highest certified winter average of 21 games or more from the previous season. If there is no certified winter average from the previous season, bowlers will use their highest certified summer average of 21 games or more from the previous season. If there is no certified winter or summer average of 21 games or more from the previous season, bowlers will use their highest certified average of 21 games or more from the current season at time of bowling (bring league standing sheet). All others must use 220 scratch. USBC Rule 319a pertaining to 10 pin increase in current average does not apply.
- 5) Tournament Management reserves the right to re-rate a bowler's average if it is determined the bowler's average was not bowled on a "house shot".
- 6) Tournament Management reserves the right to re-rate any bowler's average and to refuse entry to any bowler.
- 7) USBC Rule 319e. All bowlers shall submit themselves for re-rating and shall be re-rated before entering a classified or handicap tournament, if applicable.
- 8) USBC Rule 319d Reporting Prior Prize Winnings, does not apply to this tournament.
- 9) USBC Rule 327 - Scoring Process is in effect for this tournament.
- 10) Multiple participation is permitted. In order to place more than once in the prize list for position standings, team players must change as follows:
 - Team Event: A team is made up of four bowlers. At least two players in the lineup must be different.
 - Doubles Event: A doubles team is made up of two bowlers. At least one player in the lineup must be different.
 - Singles Event: The same individual may not place more than once.
 - All Events: The bowler's first appearance in each event counts toward the All Events total.
- 11) Report all substitutions to the Tournament Office when signing in.
- 12) In case of injury, disability, or emergency, after a game has started, in Team or Doubles, a substitute will be permitted if one is available. Handicap shall be prorated according to averages of both bowlers involved. If no substitute is available, the disabled bowler's actual score will count for the frames bowled.
- 13) Entries will be scheduled according to requests if possible and in the order received. The schedule will not be changed by the tournament manager except for emergency.
- 14) No refunds of entry fees paid.
- 15) Team, Doubles, Singles and All Events prizes will be based on highest total pins with handicap. Actual Champions will be recognized. Handicap Event Champions will receive championship jackets. Handicap Champions will be offered one free admission per bowler to the Tri-County Hall of Fame Banquet.
- 16) Prize fees returned 100%. Prizes will be based on a minimum of not less than one prize for every ten (10) entries. All Events will be based on a minimum of not less than one prize for every twenty (20) entries.
- 17) Entry fees must be paid in full with the submittal of the entry form. All Events is included in your entry fee.
- 16) USBC Rule 17B. 1 "Engaging in improper tactics or conduct in connection with the game of bowling including, but not limited to, physical and verbal abuse toward other persons." Membership may be suspended or denied to anyone who is involved in a violation of this rule.
- 18) Lanes will be assigned by the tournament manager. Check-in time is 30 minutes prior to bowling.
- 19) Protests and appeals must be in writing stating the grounds for protest or appeal. A protest involving eligibility or playing rules must be filed with tournament management within 72 hours of the infraction, or prior to tournament prizes being paid, whichever occurs first. The decision of the tournament management shall be final, unless a written appeal is filed with the local association or USBC Headquarters within 10 days of notification of tournament management's decision.
- 20) Tournament play will begin at the stated times on the front of the entry form.
- 21) Handicap tournament entrants may enter OPTIONAL SCRATCH EVENTS by completing the entry form and submitting the entry fee. Entrants must submit Optional Scratch fund fees with entry for each Optional Scratch event entered. To be eligible for Optional Scratch Events individuals/teams must enter the Handicap Tournament events and will use scratch scores bowled in those respective Handicap Events. A separate prize list will be established for Optional Scratch Events. Optional Scratch Events entrants may cash in each Optional Scratch event up to the number of times entered.
- 22) All Items not covered by these rules will be referred to USBC rules.
- 23) **PROFESSIONAL PBA CARD CARRIERS:** All Bowlers who are Professional PBA Card Carriers at time of BOWLING are Limited to 2 on Four Bowler Team and 1 on a Two Bowler team (Doubles). Automatic disqualification for failure to comply!
- 24) At the Tournament Manager's discretion, additional squads may be added.

THE ENTRANTS WHOSE NAMES APPEAR HEREON OR THEIR AUTHORIZED REPLACEMENTS HEREBY AGREE THAT THE SUMMIT COUNTY USBC, ITS OFFICERS AND AGENTS SHALL BE LIABLE ONLY TO THE EXTENT OF RETURNING ENTRY FEES IF AND WHEN THESE ENTRANTS SHALL BE PREVENTED FROM BOWLING ANY EVENT IN THE TOURNAMENT THROUGH PREMATURE TERMINATION OF THE TOURNAMENT WHICH MAY BE BROUGHT ABOUT BY WAR, NATIONAL EMERGENCY OR EMERGENCIES, OR CASES RELATING THERETO OR RESULTING THEREFROM FIRES, STRIKES, LOCKOUTS, LABOR DIFFICULTIES OR OTHER CAUSES BEYOND CONTROL OF THE SUMMIT COUNTY USBC.

WEATHER: Summit County USBC reserves the right to cancel tournament or scheduled shifts due to inclement weather conditions.
