Membership Fee Information (valid 8/1/2023 – 7/31/2024)

Membership Fee Structure (good from 8/1 to 7/31 each season)

- \$23.00 national, state and local fee per bowler, not certified any other league/association The regular certification fee for a bowler who has **NOT** been certified anywhere else is \$23.00 (\$15.00 national dues, \$2 state dues and \$6.00 local association dues).
- \$10.00 USBC Basic membership, not certified any other league/association, short season league The basic certification fee for a bowler who has **NOT** been certified anywhere else is \$10.00 (\$7.00 national dues \$3.00 local association dues). For leagues that bowl 16 weeks or less.
- **§6.00** local fee per bowler if already national certified outside the Summit County USBC If a bowler has been certified thru a league **outside** the county (example Cleveland, Portage County, Medina, Canton), then that bowler needs to pay the \$6.00 local fee.
- **\$0.00** if already certified thru another league within the Summit County USBC If a bowler has already paid the certification fee in another local certified league then he/she pays nothing but still has to fill out a membership card.

Travel League Explanation (good from 8/1 to 7/31 each season)

- If a bowler is in a traveling league that is certified in the Summit County USBC, membership fees are required per the outline above.
- If a bowler is bowling in a traveling league that is **not certified in the Summit County** USBC, membership fees are not required for that league, however, if that bowler would like to bowl in a different league that is certified in the Summit County USBC, then local membership fees are required per the outline above.

Note

- Membership purchased after March 15th is valid for the balance of the current season only and will expire on July 31st of season purchased.
- All adult league members must pay or show proof of payment of USBC dues and the required association membership fees prior to the completion of the bowler's first series.
- Secretaries have 30 DAYS from the collection of fees to send the material in. Once the Membership cards and Money have been collected and the appropriate forms completed, please send the membership information and a copy of your most current standing **sheet** to the: Summit County USBC



What should you do if a bowler in your league bowls a 300 game, 800-900 series?


It is your responsibility <u>as secretary of your league</u> to complete the high score award application. Several applications have been included in your league materials for the new bowling season. The application is gray and the front portion has to be completely filled out and sent to our office within <u>20 DAYS</u> of the date of the honor score. This form <u>does not go to National Headquarters</u> but to our office in Rootstown.

If a bowler does not know his/her ring size (if the bowler elects to get a ring) then give him/her our phone number (330-899-9643 or 1-866-899-9643) and have them call to give the ring size to us. **DO NOT HOLD THE APPLICATION WAITING FOR A RING SIZE**. Please send us the Application without the ring size we will take care of the rest.

REMEMBER it is your responsibility to get this completed award score application form to our office within the **20 day limit**. The quicker we process it the quicker the bowler receives their award.

<u>A SAMPLE</u> of the front of the application is on a following page. If you don't have an original form please make a copy of this form and send the completed copy to our office. Use this **ONLY** if you do not have a original one to use.
